I. Call to Order and Welcome Remarks – MCIA Sherry Ayers

Director Colston requested that we bring all the Chairs from each Commission together to work more closely to help one another out. He also would like to see more statistical information provide from Maryland Department of Health for the Native American Indigenous People.

Madam Chair Ayers inquired if anyone has been keeping track of the vaccinations by Ethnicity and Director Colston replied that he guesses that they are. Commission Lessard said that MDH does have raw data, but they don't report it.

Ongoing initiatives with Anne Arundel County Food Bank. There hasn't been a lot of activity with Susan Thomas due to COVID, but we need to activate the MOU (Memorandum of Understanding) with them. AACOFB worked will us to obtain two storage areas in Baltimore City that are free of charge that still contains items. Madam Chair Ayers wanted ideas on how to get tribal communities to partnership with non-profit organization, like (AACO Food Bank vs. CIAA Basketball Tournament) to obtain opportunities. Vice Chair Bowen asked how funds can be spent. We can accept any source of funding for the MCIA commission. We could develop "Friends of MCIA'. The Governor's Office of Community Initiatives would oversee these funds.

V. Open Meetings Act – Director E. Keith Colston

It is the policy and procedures of Governor's Office of Community Initiatives, Ethnic Commissions-including MCIA for the Chair and Vice Chair to take this training. During meetings the public has no legal right to interject or speak, unless they were invited as a presenter, or they made a proper appointment with the Director of Ethnic Commission or the Chair or Vice Chair. Closed Sessions are vital for us to cover ourselves in a legal and procedural manner and to protect the Administration-Governor-MCIA Administrative Director. There is a procedural process to have a closed session meeting. You need to have a Motion and 2nd Motion to close the meeting. The public does have the right to audio or video record the meetings, without any disruption of the meeting. There must be a Quorum to hold a meeting.
