She was the one that pushed legislation to pass August as Maryland's Caribbean Heritage Month. He would like Commissioners to create a 30 to 45 second video highlighting what Caribbean Heritage means to them. This will be placed on GOCI's social media. This will include videos from the commissioners and community leaders. GOCI will provide the commissioners with guidelines for the videos. The commission will bring ideas for the planning of the event. He will need an invitation list from the commissioners that include ambassadors, etc. Entertainment could include steel drums, other instruments and vocalist. Try getting a sponsor(s) for food. He would like the Commission to partner with other events that are happening. Chair Curtis Ward



would like the declaration to take place early in the month of August. Director Walker has asked for August 1st or 4th.
