It will be up to the Governor-elect and his new administration on how the Commission will continue, whether the seats that are currently expired, but were extended by Governor Hogan. will be vacated or not. V: Commissioner Events:

VI: Commissioner Business

Guest Melissa Tyson from the State Department said she will be presenting at one of upcoming meetings concerning Federal Employment and Public Service. Commissioner Elizabeth Chung inquired about the posting of the Annual Report. Director Christina Poy stated that she submitted 2019, but COVID hit, and the report was submitted to communications, but it was never published. Project Coordinator Cheryl Madigan states the year 2020 is when the COVID pandemic started, and it carried through into 2022. In 2021, commission meetings started being held via Zoom and in person events were very limited. The current year 2022 is not due to be posted until 2023.

Chairman Hung-bin Ding asked that the upcoming annual report be completed as soon as possible, and if it could be done by the end of the Hogan administration.

Commissioner Beth Wong asked if it would be possible to have a gathering with Governor Hogan and First Lady Hogan before the end of the administration and Director Poy responded that there could be a Lunar New Year event before January 18th. Commissioner Wong also inquired about the special funds and if this was reported to the new administration and if the monies could be used for any events. Director Poy replied "Yes" and that the monies are airmarked for business conferences or seminars. Also, Commissioner Wong suggested having a reception with the General Assembly, Public and the Commission. She asked Cheryl Madigan to inquire about the availability with the Banneker Douglass Museum for the venue around the last week of January or first week of February. Cheryl will check this out when she receives more concrete information from Commissioner Wong. This event would only be organized Asian Pacific American Affairs and South Asian American Affairs commissioners for their communities.

Commissioner Dottie Li brought up Asian Pacific American Heritage Month 2023 – She would like everyone to start thinking about the planning of it and she suggested having a business conference.

Commissioner Mi Schill suggested that the commission have a get together before January 18th. Commissioner Wong suggested having a happy hour or meet and greet. This could be an ongoing thing and could start in Howard County. Director Poy stated this would not be commission related due to the Open Meetings Act and it should be a non-commission gathering.
